- 1. The CEPC chair would like to, once again, personally thank the vice chair and the secretary of CEPC as well as the vice provost for their continued work and input as part of the CEP Steering Committee. The Committee met often. The chair recommends that the CEP Steering Committee continues to meet on a regular basis in the future.
- 2. CEPC held a discussion during the Organizational Meeting for 2022-23 in May 2022, and the consensus seems to be members would prefer to *stay* on Zoom for meetings in the coming AY. CEP Steering will discuss this again before the beginning of the fall, but that is the current opinion of CEPC at large.
- 3. As directed, CEPC did *not* propose substantive changes to what is at this moment called the "Policy on Probation and Disqualification" (aside from the ones on which CEPC and Senate Exec had previously agreed). However, CEPC would like to formally request, once the Senate at large has addressed the nomenclature and other initial changes CEPC has proposed, that the Council does have a chance to address other, more substantive policy matters in the document. Council members have already raised a number of such suggestions, which were noted in our minutes for future discussion.
- 4. The CEPC chair would like to thank Senate Exec for inviting us to offer input on proposed the changes to CEPC charge to possibly adding new members to its roster.
